- Vessels of amateur construction or a conversion.
- Vessels that are registered to anywhere outside UK, Isle of Man, Jersey or Guernsey

THIRD PARTY LIABILITY ONLY

What is the purpose of this product?

Powerboats, sailing boats, cruisers, sports boats and RIBS customers requiring liability cover only relating to use of their boat.

- Vessels that are registered to anywhere outside UK, Isle of Man, Jersey or Guernsey
